No.NBE-1/Ex-9/2015-16/2283 :: In supersession of this Office Notification No. 30/2015 dated Kohima, the 29<sup>th</sup> September 2015, it is hereby notified that the Class IX Final Examination 2015 is postponed and rescheduled due to reported theft of the confidential packets on 20<sup>th</sup> November 2015 after collection from the Board's Office by Mount Hermon School, Purana Bazar, Dimapur.

The Class IX Final Examination 2015 shall now be held from **28<sup>th</sup> November 2015** to **14<sup>th</sup> December 2015**. The revised routine is being published separately. The Examination of other classes should not be affected by this change of schedule.

The Board shall issue the new question papers for **English**, **Mathematics**, **Science**, **Social Sciences**, **Alternative English** and **Environmental Education** subjects. For the remaining subjects, schools shall use the question papers already issued by the Board. The new question papers shall be delivered in the district headquarters on the 3<sup>rd</sup> and 4<sup>th</sup> **December 2015** by the Board Officials. Schools under Kohima district shall collect it from the Board's office.

The Heads of Institution shall collect the confidential packets on the specified dates from the respective district designated schools.

As an immediate penal action, the examination centre for Mount Hermon School, Purana Bazar, Dimapur is cancelled. The centre of Class IX Final Examination 2015 for this school shall be Bethesda Higher Secondary School, Dimapur. Further course of action will be initiated as per rules.
