Q31. Zomato is a restaurant search and discovery service founded in the year 2008. It currently operates in 23 countries, including India, Australia, and the United States. It provides information and reviews on restaurants, including images of menus even when the restaurant does not have its own website. On 18th May 2017, the Indian branch of Zomato became the target of hackers. A security blog called Hack read claimed over 17 million accounts had been breached. Zomato confirmed that names, email addresses, and encrypted passwords were taken from its database. The company reassured affected customers that no payment information or credit card details were stolen. Zomato said that the security measures it uses to ensure the stolen passwords can't be converted back into normaltext.
